- Large / Mid-cap focus

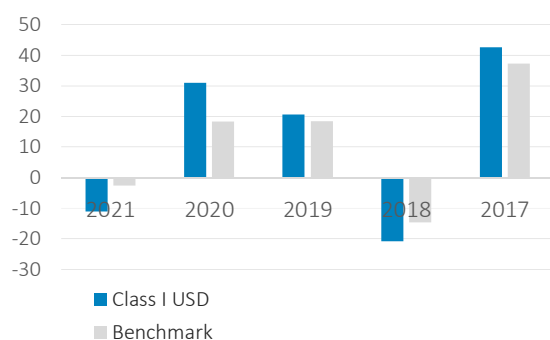

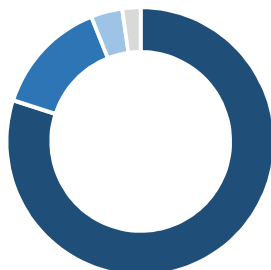

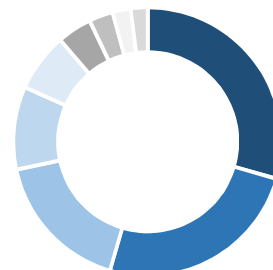

Manager Commentary

The MSCI Emerging Markets Index returned +0.4% in May. Latin America (+8.2%) was the strongest performing region followed by Emerging Asia (+0.4%) while EMEA (-4.2%) declined. The three strongest performing sectors were IT (+3.2%), energy (+2.6%) and industrials (+1.9%) and the three weakest performing sectors were real estate (-3.7%), healthcare (-3.4%) and financials (-1.2%).

Contributors to Fund performance included: Brazilian car rental operator **Localiza**, which reported better-than-expected results for the first quarter; Chinese solar manufacturer **LONGi**, whose shares recovered somewhat following a period of weakness; and restaurant group **Yum China**, whose share price rose as COVID-related restrictions in cities such as Shanghai were eased.

Detractors from performance included: Latin American digital leader **MercadoLibre**, whose shares were weaker in May despite reporting robust first quarter results; Chinese e-commerce group **JD.com**, whose shares reversed the gains made in the previous month; and **Becele**, the Mexican owner of the Cuervo tequila brands, whose shares sold off following an initially positive response to quarterly results that were comfortably ahead of expectations.

If a company is engaged in a practice that concerns us, we will engage with the company on the issue, seek to learn more about it and encourage positive change.

Firearms or small arms ammunition

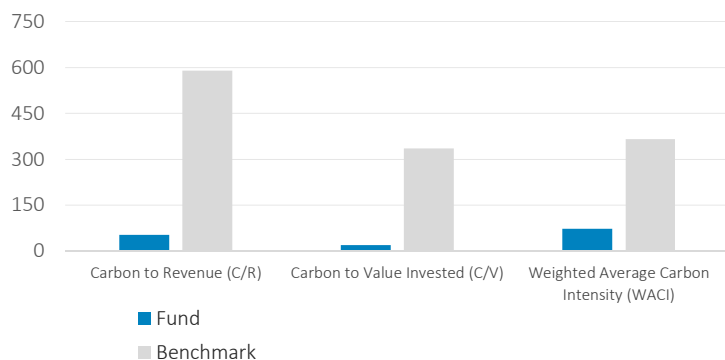

Carbon Intensity



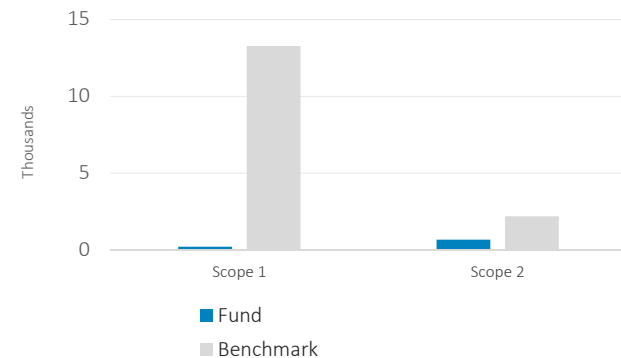

The Carbon to Revenue (C/R) metric shows the intensity of the portfolio and benchmark using the absolute apportioned carbon emissions and apportioned revenues, calculated on an ownership basis (value of holdings divided by chosen apportioning metric), as at the analysis date. The Carbon to Value (C/V) Invested metric takes the carbon emissions (apportioned using either market capitalisation or enterprise value) divided by the value of holdings in a portfolio or benchmark. The Weighted Average Carbon Intensity (WACI) metric takes the carbon intensity (total carbon emissions divided by total revenue) of each holding and multiplies it by its investment weight (the current value of the holding relative to the current value of the whole portfolio).
