## Investment Objective

The investment objective of the Fund is to seek long-term growth of capital with lower than market volatility by investing primarily in equity and similar securities issued by high quality companies listed on Recognised Markets in countries which are members of the Organisation for Economic Co-operation and Development ("OECD").

- Focused "total immersion" bottom-up analysis of selected "high confidence pool" of stocks
- Concentrated global equity long-only strategy with 20-25 high quality growth companies

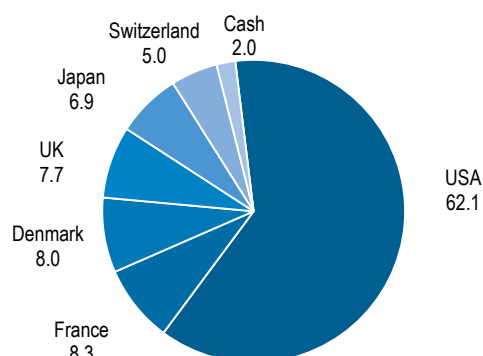

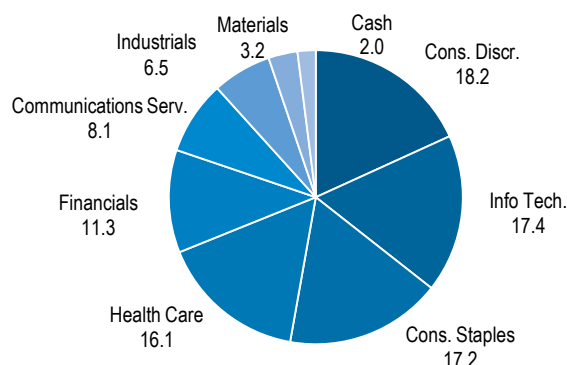

## Manager Commentary

The top contributors year to date were **Illumina**, **MarketAxess** and **Reckitt Benckiser**.

**Illumina** is the leading producer of gene sequencing equipment and associated consumables. COVID-19 has highlighted the importance of understanding the link between genetics and virus susceptibility and should be the catalyst for faster adoption of population gene sequencing by governments around the world. **MarketAxess**, the leading electronic bond trading platform, benefited from increased volatility in the bond market and the move to working-from-home. Q2 quarterly trading volume grew 44% year-over-year, reaching record levels. Volumes on Open Trading, its proprietary all-to-all trading platform, grew 87% year-over-year. **Reckitt Benckiser** is in a strong position to benefit from lasting, COVID-19 related changes to consumer behaviour, thanks to its ownership of market-leading disinfectants, Dettol and Lysol, and strong brands that can break the chain of infection, including Mucinex, Lemsip and Durex.

The top detractors year to date were **Booking Holdings**, **Ulta Beauty** and **CME**.

**Booking Holdings**, an online travel agency, has seen an unprecedented drop in hotel room nights, car rental days and flights booked due to disruption to travel caused by the COVID-19 pandemic. The company's financial strength and variable cost structure should enable it to withstand the near-term volatility and, as global travel recovers, the trend toward online bookings and integrated travel offerings should resume. **Ulta Beauty**, a US specialty retailer, was forced to close all of its 1,266 stores due to the COVID-19 pandemic. The stock was sold in Q1 and, in the light of positive market moves since then, remains a top detractor year-to-date. **CME**, the world's leading derivatives marketplace, reported a 16% decline in volumes in Q2. Exceptional levels of market volatility drove strong volume growth across asset classes in Q1, but government intervention in fixed income markets has successfully stabilised markets, kept interest rates low and dampened market volatility ever since.
